## Vocabulary

Naturalized: when a person born in another country to non-United States parents can become a citizen of a different country (usually after living in the new country for a specified amount of time)

Republican: a United States political party; people who believe in the same or similar political ideas Disenfranchised: deny (someone) the right to vote

Wards: usually a child that is in the care or protection of a legal guardian or government; in this case, Native Americans – adults as well as children – who were under the legal care of the United States government

## Key Events in Relation to Suffrage in the United States

<b>1870 – 15th Amendment:</b> Voting for United States citizens cannot be denied on the basis of race. Native Americans were not U.S. citizens, they were considered wards of the state so they could not vote.		1875 - Jim Crow Laws: State laws to limit voting for Black, Chinese and other races of men born in the U.S. by requiring a tax, property, or literacy test to vote.
<b>1882 – Chinese Exclusion Act:</b> Chinese immigrants denied U.S. citizenship; Chinese immigrants cannot vote.	1900
