

#RevolutionaryVision Photo Station Contest

RULES AND ENTRY REQUIREMENTS: Entrants must post a photo to Facebook, Instagram, or Twitter, and use the hashtag #RevolutionaryVision to be eligible to win a prize (approximate value: \$40). The entrant must have a publicly viewable social media account and post a photo during the submission period. The deadline for the #RevolutionaryVision Photo Station Contest ("Contest") submissions is January 8, 2017, at 11:59 p.m. Pacific time. Entries will be judged based on creativity and photographic quality. One winner will be selected each month between June 2016 and January 2017. The Contest schedule is subject to change.

Entrants grant the Autry Museum of the American West ("the Autry") the right to use and publish their social media handle and photo submission in print, online, and in any other media in connection with this Contest. All images will be credited with the social media handle and/or name of entrant. Acceptance of a prize constitutes permission for the Autry to use winner's name, photos and likeness for advertising and promotional purposes without additional compensation.

Image Modifications: Entrants are welcome to use Photoshop, Instagram, or other tools to modify digital images. Images may be cropped, resized, rotated, and filtered.

Entries that are lost, late, misdirected, illegible, unintelligible, or incomplete, for any reason, will not be eligible. The Autry is not responsible for computer system, hardware, software, or program malfunctions or other errors, failures, or delayed computer transactions or network connections that are human or technical in nature. By entering, you represent that your photograph has not been copied from others, and does not violate the rights of any other person or entity. Any intellectual property infringement, misuse or plagiarism of another person's work in any form or state will result in immediate disqualification and forfeiture of eligibility to receive a prize.

By entering the Contest and/or accepting a prize, to the maximum extent permitted by law, you agree to release and hold harmless the Autry and its judges, officers, employees, representatives, agents, and any party associated with the development of the Contest from any and all liability for any injuries, losses, damages, legal claims, costs, demands, or actions of any kind, arising in whole or in part, directly or indirectly, from acceptance, possession, use, or misuse of a prize or participation in this contest. To the maximum extent permitted by law, you agree to indemnify the Autry against any liability, claims, demands, losses, damages, costs, and expenses (in each case, whether direct or indirect) resulting from any act, default, or omission by you and/or a breach of warranty by you, or any breach, non-observance, or omission of these rules by you, whether negligent or otherwise. In addition, by entering, you agree that the Autry shall have no liability for any accidental disclosure or identification of any entrants. To the extent permitted by law, the rights to litigate, to seek injunctive relief, or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Contest, are hereby excluded, and you expressly waive any and all such rights.

The Autry reserves the right to cancel, terminate, or modify the Contest if it is not capable of completion as planned due to, for example, infection by a computer virus, bugs, tampering, unauthorized intervention, or technical failures of any sort. In no event will the Autry be responsible for any damages or losses arising out of access to and use of the social media sites.

The Contest is not open to employees, agents, or representatives of the Autry or any member of their immediate family. Immediate family includes only spouses, parents, and children.

There is no cash alternative to the prize. Odds of winning depend upon the number of eligible entries received. Void where prohibited by law.
